
The 1st Year B.Ed (Reg/Back) Examinations-2020 will be held through Online Mode with guidelines as prescribed below in view of COVID-19 Pandemic situation.

GUIDELINES PRESCRIBED FOR CONDUCT OF ONLINE EXAMINATIONS:

1. The examination for theory papers shall be conducted through online mode.
2. The full marks in each theory paper carries 80 marks. Out of which 40 marks objective type and 40 marks long answer type. For objective question the time limit is of 01 (one) hour. For long answer type time limit/ duration is of 02 (two) hours.
3. Examination shall be conducted in two phase i.e. objective type questions will be given through Google form. The candidates have to answer it by clicking the link through their smart phone/laptop/desktop and submit it. 20 nos. of questions will given which carries 02 marks each. Question may be filled in the blanks/true false/alternative response/matching /single word type. No questions will be given from multiple choice format. In case of long answer type 06 nos. of questions will be given out of which 04 nos. of questions need to be answered. Each question carries 10 marks . There shall be a gap of 10 minutes between the objective and long answer type Examination.
4. The Questions of the respective Papers are to be sent to the college mail id in the stipulated time. The college authorities will ensure sending Questions to their valid students through online (E-mail / WhatsApp) mode before 10 minutes of commencement of Examination.
5. The students will write the answer in A4 size paper at their home and word limit for each long answer type question is 200 words. The students are instructed to scan the answer scripts properly and create a single pdf-file of his/her answer and mail the same to the concerned email is given by the concerned College authority. No answer shall be accepted after 10 minutes of the Examinations hour. If any script is found to be difficult for valuation due to improper scanning or part scanning, no mark can be awarded for the same. The concern candidate will be responsible for the same.
