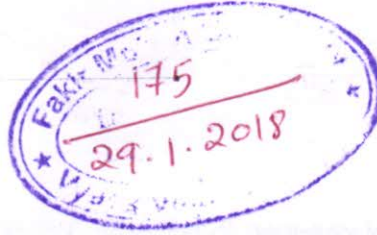

The undersigned is directed to enclose a copy of the letter number F.No.11-10/2017-U.II dated 23.11.2017 & F.No.11-4/2017-SC/ST dated 30.11.2017 received from Ministry of Human Resource Development, Department of Higher Education, New Delhi on the subject mentioned above along with its enclosures with a request to provide the action taken report on the following recommendation is reproduced as below

- To issue appropriate instructions for implementation of reservation of 5% of seats in every Government and Government aided higher educational institutions in terms of section 32 of the Act (extract enclosed).
- To work out mechanism for orientation and sensitization at college and university level regarding rights of PwDs in terms of section 39 (2) (d) (extract enclosed) and also to include rights of persons with disabilities in the curriculum in the colleges and universities in terms of Section 39 (2) (f) of the Act (extract enclosed).
- To issue general instructions to all the establishments under its control regarding implementation of other provisions of the Act.
- Chapter-III of the above mentioned Act have provisions listed for Education Sector. It is observed that this Act envisages provisions for ensuring inclusive education to children/students with disabilities.

The undersigned is directed to refer to SC/ST Cell's O.M. of even No. dated 25.5.2017(Copy enclosed) forwarding a copy of Secretary, D/o EPwD's D. O. No. 3-1/2017-DD-III dated 2.5.2017 alongwith a copy of the Rights of Persons with Disabilities Act, 2016 has been brought into force w.e.f. 19.04.2017 and notified on 28th December, 2016, with request to take specific action in respect of the following:-

- To issue appropriate instructions for implementation of reservation of 5% of seats in every Government and Government aided higher educational institutions in terms of section 32 of the Act (extract enclosed).
- To work out mechanism for orientation and sensitization at college and university level regarding rights of PwDs in terms of section 39(2)(d) (extract enclosed) and also to include rights of persons with disabilities in the curriculum in the colleges and universities in terms of Section 39 (2) (f) of the Act (extract enclosed).
- To issue general instructions to all the establishments under its control regarding implementation of other provisions of the Act.

2. In view of above, Bureaus of D/o Higher Education are once again requested to ensure effective implementation of the provisions of the RPwD Act, 2016, and Action taken in this regard may be intimated directly to D/o EPwD, endorging a copy to SC/ST Cell.
